(GRRV) Government Receipts Management

Supports revenue and tax collection.

(GRCS) Cashiering

Supports multiple cashier stations, with proper audit trail per cashier and daily reconciliation processes. Manages different payments methods, bank deposits, print receipts and automatically generates revenue budget execution transactions.

(GRPL) Permits and Licensing

Manages corporate and professional academic licenses and permits.

(GRCE) Customs Taxation

Customs software that supports the processing of taxation as well as import tariffs.

(GRCT) Corporate Income Tax Administration

Integrated tax data architecture providing a single view of taxpayers' history. Improves revenue generation and enables tracking while also reducing fraud and non-compliance issues. Enables management of complex policy and legislative changes.

(GRPI) Personal Income Tax Administration

Provides case management functionality including revenue and payments as well as fraud detection and audit.

(GRPT) Property Taxes

Calculates corporate and personal property taxes. Provides functionality to bill, maintain, collect, distribute and track properties and associated taxes. Capability to adjust property class codes, interest calculations for delinquent taxes, levies and taxing authorities, as well as tracking transfers of ownership.

(GRBP) Bill Presentment

Supports the electronic presentation of bills including statements, utility billing and to-date billing.

(GRCM) Case Management

Assists with the automation of collections, correspondence and case details with a built in workflow for case processing, reviewers and approvers. The system also provides case tracking metrics and the ability to export case information to PDF, MS Word and Excel formats.

(GRCR) Customer Relationship Management

Generalized e-sales and e-invoice functionality that helps to drive sales productivity and market effectiveness through social insight and business intelligence. Includes customer data management, workflow and reporting capabilities.

(GRUB) Utility Billing

Billing for utilities like water and gas including collection management functionality. Allows consumers to enter meter readings into a meter reading worksheet. Imports data from the computer and export via PDF, MS Word and Excel. Payments, adjustments and charges are posted real time to customers' accounts.

Permits and Licensing

- Manages permits, licenses, certifications, user fees, fines and other government processes that collect revenue.

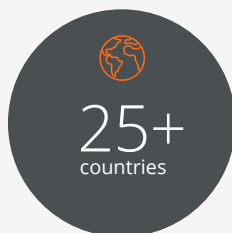
